

Towards a statement of shared values and principles

The Past (1)



- Idea goes back to 2005, revived in 2009
- Two EACEA coordinators meetings in 2009: February (60 participants), October (100 participants)
- All coordinators of EM A1, A2, A3 informed in December 2009 (through EACEA)

The Past (2)



 February 2009 meeting: (re)definition of general principles, creation of a working group on voluntary basis

 October 2009 meeting: presentation of bylaws/statutes, discussion on membership, extension of scope to include A2, fees

The Past (3)



- January 2010: « kick-off » meeting in Bruxelles outside EACEA context
- Invitation to all current EM coordinators
- Definition of a group of coordinators to draft bylaws
- Good feedback (13 countries, >45 EMMC, 7 EMJD, > 12 EMA2, ...) but low attendance ...
- Solution: IDEA = creation of an Action 3 project to build trust and substance through time

The future



To take into consideration:

- In spite of the position paper, the Association / Concilium is to make sense even if *Erasmus for* All does not keep the *Erasmus Mundus Brand* Name.
- The Concilium is inspired by the ideas underlying the EM programme and not only its existence.

- Proposed values, principles and aims: listed in the next slides from general to more specific (source: draft bylaws)
- Remark: Project Activity 'Needs Analysis' will also have an impact
- Reflective process: future input welcomed





- to contribute to the **promotion** of European higher education institutions and notably their centres of excellence and their educational programmes
- to contribute to the definition of European higher education policies
- to encourage structured cooperation with higher education institutions in and outside Europe

- encourage structured cooperation with Higher Education Institutions in Europe and outside the EU and student, teacher and staff mobility in Europe and between the EU and third countries
- To provide support and services to individuals and institutions sharing the values of the association
