Idea goes back to 2005, revived in 2009

Two meetings in 2009: February (60 participants), October (100 participants)

All coordinators of EM A1, A2, A3 informed in December 2009 (through EACEA)

Good feedback: 13 countries, >45 EMMC, 7 EMJD, > 12 EMA2, ...

December 2009: creation of *em-concilium* web site

- Members and Constituents have to satisfy eligibility critera
- Individual members are elected by the Executive committee
- Constituents are elected by the Assembly









- Voting in the Assembly is by double majority
- To be accepted, a proposition has to be accepted by both Members and Constituents
- Members and Constituents cannot impose a decision on one another
- Constituents meet in the Constituent council









Bodies in the Association:

- (General) assembly
- Executive committee and President
- Constituent council









The Executive committee:

- is composed of Full members
- nominates and has responsability over the *Treasurer* and *Secretary*
- executes the decisions taken by the Assembly
- conducts the general business of the Association
- proposes the budget and prepares a financial report to the Assembly

Definition of first task forces (1)

- Task force 1: support for joint international programmes (JIP). How to make JIPs sustainable? Which tools and services are available for the management of JIPs? ...
- Task force 2: *monitoring and strategy.* How are JIPs evolving? How can JIPs contribute to the development of the European Higher Education Area and to the cooperation with Third countries? ...
- Task force 3: communication and networking. Promote the Association's activities. Strengthen the ties among its members and with the Association's partners. Reach out to a larger audience ...









Definition of first task forces (2)

- Task force 4: training and consultancy. Contribute to the (on-going) training of the professionals in charge of the coordination and the management of JIPs. Help institutions design, develop and promote JIPs ...
- Task force 5: conferences. Organise the Association's annual Congress and other major events.
